ZVA MOBILITY DISTRIBUTION INDICES

The ZVA Mobility Distribution Indices measure the market activity of a geographical unit—in this case county or county equivalent (mainly parishes in Louisiana and independent cities)—in relation to its share of the total market under examination.

METHODOLOGY-

The ZVA MOBILITY DISTRIBUTION INDICES represent—for a county or county equivalent—the ratio of household movers compared to state household movers (ZVA STATE MOBILITY DISTRIBUTION INDEX) and to national household movers (ZVA NATIONAL MOBILITY DISTRIBUTION INDEX), divided by the percentage of the county's total households compared to the total households in the state and in the nation.

The ZVA STATE MOBILITY DISTRIBUTION INDEX is calculated by dividing the annualized number of households that moved within or into a county compared to all households moving within or into the state, by the ratio of the county's total households compared to the total households in the state.

The ZVA NATIONAL MOBILITY DISTRIBUTION INDEX is calculated by dividing the annualized number of households that moved within or into a county compared to all households moving within or into the nation, by the ratio of the county's total households compared to the total households in the nation.

MIGRATION AND MOBILITY DATA-

State-to-state and county-to-county migration are based on the year-to-year changes in the reported addresses on returns in the Internal Revenue Service Individual Master File system. Data on migration patterns by state, county, or county equivalent (mainly parishes in Louisiana and independent cities), for the entire United States, include taxpayer inflows and outflows.

The American Community Survey produces estimates of in-migrating population by origin. Residents previous address' location one year ago are categorized by: same municipality within the same county, same municipality from another county, other locations within the same county, different counties within the same state, different counties within the United States, and also foreign addresses.
